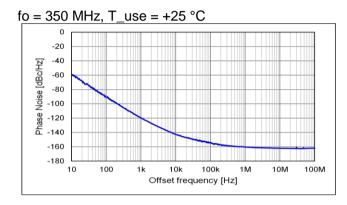

(1) Output Waveform and Level



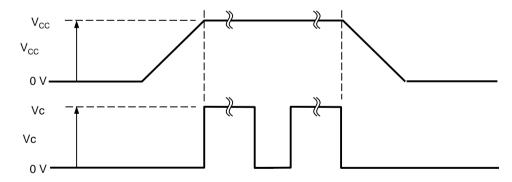
